




### Different Services – Different Revenue Sources

# Villages

- Located near each other or remote?
- Located in a metropolitan area or not?
- Rural or urban?
- What services do they provide (e.g. water, sanitation, street lighting, roads)?
- What sources of revenue can they use (e.g. taxes and fees versus transfers)?



# Public Finance in Villages

- Challenge: to provide adequate services at a reasonable tax rate
- Services costly to provide difficult to achieve economies of scale
- Difficult to charge user fees that cover costs
- Inadequate local tax base
- Inability to borrow
- Reliance on intergovernmental transfers



## Smart Villages

- Use technology to:
  - deliver services e.g. health care
  - share jobs with other villages e.g. treasurer, planners
  - collect user fees, taxes e.g. online bill payment
  - civic engagement e.g. online surveys
